REVIEW PROCESS: The Executive Board of Zonta Club of Anchorage will review applications for eligibility. All eligible requests will be submitted to the general membership for final approval. Results will be announced in May 2017.

FINAL EVALUATION: Successful applicants are required to submit a final summary within 60 days of the end of their fiscal year, outlining how the funds were expended, and any copies of publicity recognizing the Zonta Club of Anchorage.
